AFFIDAVIT FOR ARREST WARRANT

IN THE NAME AND BY THE AUTHORITY OF THE STATE OF TEXAS

Before me, the undersigned authority, on this day personally appeared the undersigned affiant who, after being by me duly sworn on oath deposes and says that, Marc Alan Carden, hereinafter styled defendant, on or about the 11th day of January, 2014, and before the making and filing of this complaint, in the County of Collin of the State of Texas, did then and there commit the offense:

Sexual Assault Child

Affiant is **Detective Wade Hornsby** who is a certified peace officer of the Frisco Police Department and is currently participating in the investigation of this case. Affiant's probable cause for the above belief is based upon the following facts and sources of said facts:

On Monday January 13, 2014 an adult male reported to the Frisco Police Department in order to file a report on what he believed was an inappropriate relationship between his 14 year old daughter and an adult male teacher. The reporting party indicated the male in question was named Marc Carden.

The reporting party stated that on January 11, 2014 the Victim stated that she was staying the night at a friend's residence, however, after the victim left that friend showed up at the Victim's residence looking for her.

The reporting party stated that he and his ex wife attempted to get a hold of the Victim on her phone but they were unsuccessful. In an attempt to locate the Victim, the reporting party pulled his phone records from his cell phone provider and contacted a number due to the frequency it appeared on the Victims call records and because it was a number that the reporting party did not know. The reporting party stated the call went to a generic voice male but about a minute later the Victim called to tell the reporting party and his ex-wife that she was coming home.

When the Victim returned home both of her parents began to question her and the reporting party entered the number, he had previously dialed, into the Victim's phone. That number was listed under Coach Carden in the Victim's cell phone and the Victim stated that the number in question did belong to Coach Carden.

Based on the number of calls and the suspicious nature of the incident the reporting party stated he kept the phone until it was released to the Frisco Police Department. However, the reporting party stated that it looked like the Victim had deleted all messages and contacts regarding Marc Carden.

A cell phone forensic examination was conducted, via a consent search from the Victim's parents. The information from the phone, including deleted material, was pulled and burned on to a disc. A review of that information revealed communication between the 14 year Victim and an individual believed to be Coach Marc Carden. Affiant observed communication between the two discussing meeting on the day of January 11, 2014. The communication included plans by Marc Carden to secure a hotel room for the Victim and Marc Carden. It also included communication about how the Victim was to enter through the side door of the Hotel once Marc Carden checked into the establishment. Affiant was able to obtain a receipt from the hotel in question which indicated that Marc Carden paid for a hotel on the night of January 11, 2014. Check in time for the hotel was at 1500hrs. This is the same day that the 14 year old victim went missing.

In addition to the communication about the Hotel, Affiant also viewed text messages in which the Victim and


Marc Carden discuss having sexual intercourse. Specifically one such communication occurred on October 04, 2013 in which the Victim told Marc that sexual intercourse with him was painful. The text strings in question are not identified by a contact name or phone number. However, Affiant was able to deduce the other party to be Marc Carden, by the content of the messages. This content includes the Victim identifying Marc by name by stating "Marc Carden stop looking at that" as well as multiple references to Marc's kids and wife by their respective names, which were made by both the Victim and Marc Carden. It also includes messages in which the Victim states that she does not know any other Marcs.

The messages indicate that the sexual assaults occurred at known locations in the City of Frisco, Collin County TX.

Based on this information Affiant has reason to believe that Marc Alan Carden committed the offense of Sexual Assault Child by penetrating the female sexual organ of a child under the age of 17.

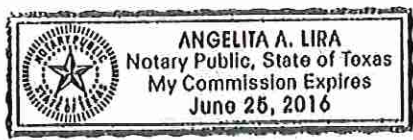
